

## NUMBER OF VISITORS

No more than three(3) adult visitors may visit one(1) inmate at a time. Minor children will be counted as one(1) against the total number of adult visitors.

## PHYSICAL CONTACT

Offenders and visitors may embrace and kiss briefly upon arrival and departure. Offenders and visitors may hold hands but shall sit across from one another in the assigned chairs. Hands must be in plain view at all times. Sexual stimulation or activity is strictly prohibited. Breast feeding is prohibited. Furthermore, neither visitors nor inmates may sit on each other's laps or between each other's legs, with the exception of small children. Excessive contact will result in denial or termination of visit.

## SEATING ARRANGEMENT

Visitation staff shall assign a table for visitors. NO visitor or offender will visit another table for any reason. Parents or guardians will maintain control of their children at all times while visiting.

## SMOKING

Tobacco products are not authorized in Lakin Correctional Center.

## RESTROOMS

It is strongly recommended that all guests use the facility restrooms located in the lobby area prior to entering the visitation room.

## ALLOWABLE ITEMS

The following items are permitted in the visitation area, ID cards, Keys( house & car), engagement ring, wedding ring all religious jewelry nitroglycerin tablets( limit 5) - no other medication is permitted, (1) belt, and (1) pair of suspenders. When an infant or toddler is visiting (up to three(3) years of age) they may have juice or milk which must be in a transparent plastic baby bottle or cup, (4) diapers, and (1) baby blanket. Visitors are not permitted to bring any items into visitation to give to inmates.

The Lakin Correctional Center's goal is to provide a comfortable, safe and enjoyable atmosphere for all visitors and offenders, while ensuring the safety and security of the public, staff and offenders. Achieving this goal, while preventing the introduction of contraband, is a difficult balance to achieve, however Lakin Correctional Center is committed to Excellence, striving to provide the best possible program for visitors and offenders.**

**ALL VISITORS MUST BE ON AN APPROVED VISITATION LIST PRIOR TO VISITATION UNLESS APPROVED BY SPECIAL REQUEST. IT IS THE OFFENDERS' RESPONSIBILITY TO NOTIFY VISITORS OF VISITOR APPROVAL.**

### **IDENTIFICATION**

All visitors are required to bring to the front lobby a vehicle registration for the vehicle that they arrive in and one form of picture identification such as valid drivers license or State I.D for persons 18 years of age and over. Officers may require further identification when necessary.

Social Security cards may not be used as a form of I.D.

Minor children shall only be permitted to visit when in the company of a parent, other adult member of the immediate family, or legal guardian. Other adult members of the immediate family must present a notarized statement from the parent or legal guardian verifying that they have issued permission for the minor child to be in that adult's company on LCC grounds for the purpose of visiting.

### **FEMALE DRESS CODE**

All female visitors to the facility are required to wear suitable, modest clothing, which includes underwear.

**NOT PERMITTED ARE:**

**Tube tops, halter tops, shorts, tight pants, sweaters, see-through blouses, sun dresses, low-cut or provocative clothing, midriff tops which allow the abdomen to be seen, under wire bra, and flip flop type shoes.**

### **MALE DRESS CODE**

All male visitors to the facility are required to wear suitable, modest clothing, which includes underwear.

**NOT PERMITTED ARE:**

**Jogging Outfits, shorts, tank tops, and flip flop type shoes.**

All visitors will be fully dressed including shoes. Only children five (5) years of age and younger will be permitted to wear shorts.

All visitors will have their person and property searched. Everyone must clear the magnometer with no exceptions other than a verified medical reason with letter of conformation from a physician. Refusal to comply WILL result in immediate denial of admittance.
